Proceed east to 90th Street.

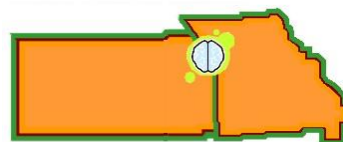
The Medical Center is located at Parallel Parkway and 90th Street.
